This MOU is for collaboration between both parties, for mutual benefit.

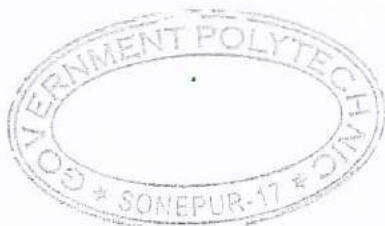
**Benefits to Government Polytechnic Sonepur Students:**
